

December 28, 2020, Carlos Eduardo Villegas Carrasco, age 22, of Hartley, IA was found guilty of the crime of Driving While Barred, as a Habitual Offender, committed on October 4, 2020. The Defendant is to pay a fine of \$855.00, a fifteen percent (15%) surcharge of \$128.25, all court costs, and court appointed attorney's fees. The Defendant is sentenced to imprisonment in the Osceola County Jail for ninety (90) days with eighty-six (86) days suspended during a one (1) year informal probation to the Sheriff.

December 25, 2020, Osceola County Deputies arrested Geronimo Velasco Perez, age 35, of Sibley, IA for alleged Assault, a Simple Misdemeanor. Velasco Perez was booked into the Osceola County Jail and held on a \$300 bond. The arrest stemmed from a report of a disturbance at a residence in Sibley.

December 23, 2020, Brandie Joy Severson, age 38, of Sheldon, IA was found guilty of the crime of Operating While Intoxicated, First Offense, committed on September 8, 2020. The Defendant is to pay a fine of \$430.00, a fifteen percent (15%) surcharge of \$64.50, the costs of this action, and restitution of any court appointed fees. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for her inpatient treatment at Keystone Treatment Center.

December 23, 2020, Narciso Flores Ramos, age 42, of Sibley, IA was found guilty of the crime of Operating While Intoxicated, First Offense, committed on August 9, 2020. The Defendant is to pay a fine of \$430.00, a fifteen percent (15%) surcharge of \$64.50, the costs of this action, and restitution of any court appointed fees. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for for time already served.

December 23, 2020, Trevor Lee Ferguson, age 20, of Sibley, IA was found guilty of the crime of Operating While Intoxicated, First Offense, committed on August 16, 2020. The Defendant is to pay a fine of \$1,250.00, a fifteen percent (15%) surcharge of \$187.50, the costs of this action, and restitution of any court appointed fees. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for five (5) days with credit for time previously served during a one year informal probation to the Sheriff.

December 22, 2020, an Osceola County Deputy arrested Rolando Ramirez Ramirez, age 33, of Frederick, MD for allegedly Operating While Under the Influence 1st Offense, a Serious

Misdemeanor. Ramirez Ramirez was booked into the Osceola County Jail and released after posting a \$1,000 bond. The arrest stemmed from a report of a suspicious vehicle at a gas station parking lot in Sibley.

December 22, 2020, an Osceola County Deputy arrested Cecelia Katherine Hanson, age 27, of Sioux Center, IA for allegedly Driving While Barred, an Aggravated Misdemeanor, Possession of Controlled Substance - Methamphetamine, a Serious Misdemeanor, Possession of Drug Paraphernalia and Operating Without Interlock, both Simple Misdemeanors. Hanson was also cited for Driving While License Under Suspension. Hanson was booked into the Osceola County Jail and released on an Unsecure signature bond of \$3,000 and her own recognizance. The arrest stemmed from a traffic stop at A22 and Highway 59.

On 12/21/2020 the Osceola County Sheriff's Office received a call of a suspicious vehicle parked at a hog site southeast of Melvin. The reporting party said he had a male subject parked on his hog site near his residence. The suspicious suspect was driving a white Ford F150 pulling a small trailer. The reporting party said he talked with the driver of the suspicious vehicle and he told the reporting party that he was having trouble with his lights. The reporting party called the Sheriff's Office to report what happened and a deputy was dispatched to the site. At about the same time the Osceola County Deputy arrived at the hog site, the O'Brien County Sheriff's Office was sending out an attempt to locate on a stolen 2014 white Ford F150 taken out of Hartley, IA. Authorities also found a 2012 Ford F250 registered to a subject from rural Melvin parked near the location where the 2014 F150 was stolen. It was later determined that the 2012 F250 was also taken without the owner's permission. Once at the hog site, the reporting party told the Osceola County Deputy that there was a red 2019 Textron side by side parked on the south side of his hog buildings. The white Ford F150 was now gone, but the trailer that had been attached to it was left behind. The plates on the trailer had been removed, but the registration was still attached to it. The trailer was found to be registered to Farmer Coop Elevator out of Sioux Center, IA. The 2019 Textron registration was run and it was registered to a subject from Melvin. The registered owners were both contacted and both the trailer and side by side were stolen out of Melvin. While the Osceola County Deputy was still at the hog site, the O'Brien County Sheriff's Office received a report of a truck and trailer in the ditch just north of Sanborn, IA. The O'Brien County Deputy arrived at the scene of the accident and found an enclosed trailer in the ditch, but no truck. The O'Brien County Deputy located several items from the stolen white Ford F150 in the ditch where the accident occurred. The trailer that was left in the ditch was registered to a subject who lives in Melvin, but it hadn't been reported stolen. The Osceola County Sheriff's Office later made contact with the registered owner of the enclosed trailer and confirmed it had been taken from his residence in Melvin without his knowledge sometime overnight. Later that morning the stolen white Ford F150 was found parked by the former Pizza Ranch building in Sanborn, IA. The O'Brien County Sheriff's Office later found video surveillance footage at Dyno's of the stolen vehicle and the person who was driving it. They also found video of the suspect entering the store. The suspect has been identified by a witness, but his name is not being released at this time. The case is still under investigation with

the Osceola County Sheriff's Office, the O'Brien County Sheriff's Office, and the Hartley Police Department. The Sanborn Police Department is also assisting in the investigation.

December 20, 2020, an Osceola County Deputy arrested Robert Thomas Johnson, age, 35, of Sibley, IA for allegedly Operating While Under the Influence - 1st Offense, a Serious Misdemeanor. Johnson was transported and booked into the Osceola County Jail. He was later released on a \$1,000 unsecured appearance bond. The arrest stemmed from a traffic stop on Hwy 9 near VanBuren Ave.

December 13, 2020, an Osceola County Deputy arrested Anthony Ray Moore, age 54, of Harris, IA for alleged Assault, a Simple Misdemeanor. Moore was booked into the Osceola County Jail and held on a \$300 bond. The arrest stemmed from a report of a disturbance in Harris.

December 12, 2020 at approximately 11:00pm, the Sheriff's Office received a report of a single vehicle accident that occurred on Oriole Ave south of 190th St. Conrado Gomez Vega, age 36, of Ocheyedon, IA was driving a 2015 Dodge Ram 3500 registered to Hornet Insulation of Sibley, IA. Gomez Vega was driving southbound when he ran off the roadway to the left and hopped an acreage driveway then returned to the roadway. Gomez Vega then veered off the roadway again and struck the concrete barrier of the bridge in the 1900 mile of Oriole Ave causing approximately \$2,000 in damage to the bridge. The Dodge received approximately \$35,000 in damage. Gomez Vega was placed under arrest for allegedly Operating While Under the Influence - 1st Offense, a Serious Misdemeanor. He was also issued citations for Failure to Maintain Control and Open Container. Gomez Vega was booked into the Osceola County Jail. He was released after posting a \$1,000 bond.

male was charged with allegedly Carrying Weapons on School grounds which is a class D Felony. The juvenile is currently being held in a juvenile detention center on the charge.

December 1, 2020, Danielle Jessin Gomez, age 28, of Sibley, IA pleaded guilty to No Driver's License. The Defendant is to pay a fine of \$250.00, a criminal penalty surcharge of thirty-five percent (35%) and the court costs of this case.

December 1, 2020, Gary C Kleve, age 71, of Ocheyedan, IA pleaded guilty to Unlawful Passing of School Bus - First Offense. The Defendant is to pay a fine of \$250.00, a criminal penalty surcharge of thirty-five percent (35%) and the court costs of this case.

November 30, 2020, Tyler Scott Davids, age 33, of Sibley, IA was found guilty of the crime of Failure to Comply with Iowa Sex Offender Registry Requirements - First Offense, an Aggravated Misdemeanor. The Defendant is sentenced to one (1) year in the Osceola County Jail with all time suspended except for seven (7) days during a one (1) year formal probation to the Iowa Department of Corrections. The Defendant shall receive credit for time previously served. The Defendant is to pay a fine of \$625.00, a fifteen percent (15%) surcharge of \$93.75, court costs, and restitution of all court appointed attorney's fees. However, the fine and 15% surcharge are suspended.

November 24, 2020, Adrienne Katisha William, age 24, of George, IA was found guilty of the crime of Possession of Marijuana, a Serious Misdemeanor committed on July 17, 2020. The Defendant is to pay a fine of \$430.00, a fifteen percent surcharge of \$64.50, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is further sentenced to thirty (30) days in the Osceola County Jail with all time suspended during a one (1) year informal probation to the Sheriff.

November 24, 2020, Jeremy Steven Vogelaar, age 36, of Sheldon, IA was found guilty of the crime of Operating While Intoxicated, First Offense, committed on September 19, 2020. The Defendant is to pay a fine of \$430.00, a fifteen percent surcharge of \$64.50, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for time already served,

November 21, 2020 at approximately 10:18pm, Brenda Leigh Beenken, age 52, of Sibley, IA was driving a 1981 Chevy C1500 southbound on Hwy 60 when she struck a deer in the roadway just before the 230th St intersection. The Chevy received approximately \$2,500 in damage. No injuries were reported.

November 17, 2020, David Darren Schwartz, age 42, of Fairfax, MN was found guilty of the crime of Operating While Intoxicated, First Offense, committed on May 15, 2020. The Defendant is to pay a fine of \$1,250.00, a fifteen percent (15%) surcharge of \$187.50, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for time already served. This sentence shall be served concurrently with the sentence imposed below.

November 16, 2020, David Darren Schwartz, age 42, of Fairfax, MN was convicted of the crime of Criminal Mischief in the 5th Degree, a Simple Misdemeanor. The Defendant is to pay a fine of \$105.00, a fifteen percent (15%) surcharge of \$15.75, all court costs, and all court appointed attorney's fees, if any. The Defendant would be sentenced to thirty (30) days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff.

November 16, 2020, Benjamin Austin Kearney, age 22, of Sibley, IA was found guilty of the crime of Driving While License was Suspended, Denied, or Revoked, a Serious Misdemeanor committed on July 23, 2020. The Defendant is to pay a fine of \$430.00, a fifteen percent (15%) surcharge of \$64.50, all court costs, and restitution of any court appointed attorney fees. The Defendant is further sentenced to imprisonment in the Osceola County Jail for a term of thirty (30) days with all time suspended during a one (1) year informal probation to the Sheriff.

On November 14, 2020 at approximately 6:00pm, Jay Roy Butler, age 51, of Sibley, IA was driving a 2005 Dodge Ram westbound on 180th St and a struck a deer east of Hood Packaging. The Dodge received approximately \$1,500 in damage. No injuries were reported.

The Defendant is to pay a fine of \$260.00 and a fifteen percent (15%) surcharge of \$39.00. The Defendant shall also pay the costs of this action, and restitution of any court appointed attorney fees.

November 3, 2020, Bradley John Johnson, age 33, of Spirit Lake, IA was found guilty of the crime of Operating While Intoxicated, First Offense, committed on March 21, 2020. The Defendant is to pay a fine of \$1,250.00, a fifteen percent (15%) surcharge of \$187.50, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for thirty (30) days and credit for thirty (30) days during his inpatient treatment at Keystone Recovery Center during an informal probation to the Sheriff. The Defendant is placed on informal probation to the Osceola County Sheriff for a period of one (1) year.

November 3, 2020, Isaiah Steven Frederick, age 21, of Swea City, IA was found guilty of the crime of Criminal Mischief in the Third Degree, an Aggravated Misdemeanor. The Defendant is sentenced to custody of the Director of the Iowa Department of Correction for a term of two (2) years with all of that time suspended except for thirty (30) days to be served during a two (2) year formal probation to the Iowa Department of Corrections. If this sentence is ever imposed, it shall be served concurrently with O'Brien Co Criminal No FECR011764. The Defendant is ordered to pay the minimum fine of \$625.00m a fifteen percent (15%) crime services surcharge of \$93.75, court costs, and the obligation to pay restitution for all court appointed attorney's fees. However, the fine and surcharge shall be suspended.

November 3, 2020, Cory John Denoble, age 47, of Ocheyedan pled guilty to the charge of Driving While License Suspended. The Defendant shall pay a fine of \$250.00, plus any surcharges and court costs as determined by the Osceola County Clerk of Court.

The Defendant is further sentenced to ninety (90) days in the Osceola County Jail with all time suspended except for four (4) days to be served. The Defendant shall receive credit for time already served during a one (1) year informal probation to the Sheriff.

November 2, 2020, Marcelino Espinoza Jimenez, age 26, of Sibley, IA was convicted of the crime of Simple Misdemeanor Assault. The Defendant shall pay a fine of \$65.00, and fifteen percent (15%) surcharge of \$9.75. The Defendant shall also pay the costs of this action, and restitution of any court appointed attorney fees. Defendant shall participate in an approved Iowa Domestic Abuse Program at the Defendant's expense. The Defendant shall be placed on informal probation to the Sheriff for a period of one (1) year.

November 2, 2020, Benjamin Elias Parsons, age 38, of Spirit Lake, IA was found guilty of the crime of Possession of Marijuana, a Serious Misdemeanor committed on January 7, 2020. The Defendant is to pay a fine of \$315.00, a fifteen percent (15%) surcharge of \$47.25, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is further sentenced to thirty (30) days in the Osceola County Jail, with all time suspended during a one (1) year informal probation to the Sheriff.

November 2, 2020, Joseph Daniel Moreno, age 26, of Spirit Lake, IA was found guilty of the crime of Operating While Under the Influence of a Controlled Substance - First Offense, committed on February 21, 2020. The Defendant is to pay a fine of \$1,250.00, a fifteen percent (15%) surcharge of \$187.50, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for six (6) days four (4) hours and sixteen (16) minutes during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for time already served.

October 28, 2020, Julio Cesar Ortiz Vargas, age 36, of South Sioux City, NE was convicted of the crimes of No Driver's License and Open Container, both Simple Misdemeanors. The Defendant is to pay a fine of \$520.00 and a fifteen percent (15%) surcharge of \$78.00. The Defendant shall also pay the costs of action, and restitution of any court appointed attorney fees.

October 27, 2020, Clinton Kreykes, age 38, of Sheldon, IA pled guilty to the crime of Trespass 1st Offense. The Defendant is to pay a fine of \$200.00, court costs, and crime services surcharge of 15%.

October 25, 2020, an Osceola County Deputy arrested Wesley Gerald Hanson, age 30, of Ocheyedon, IA for alleged Domestic Assault - Impeding Air/Blood Flow Causing Bodily Injury, a Class D Felony and Possession of Drug Paraphernalia, a Simple Misdemeanor. October 23, 2020, Osceola County Deputies arrested Dustin Lee Gust, age 39, of Sibley, IA for alleged Assault on Persons in Certain Occupations - Intent of Injury, a Class D Felony, Assault with Intent to Inflict Serious Injury, an Aggravated Misdemeanor, and Domestic Abuse Assault - Injury or Mental Illness 1st Offense, a Serious Misdemeanor. Gust was booked into the Osceola County Jail and released after posting a \$500 bond. The arrest stemmed from a report of a domestic incident at a residence in Sibley.

October 20, 2020, Ricardo Morales Romero, age 34, of Sibley, IA was found guilty of the crime of Operating While Intoxicated, Second Offense, an Aggravated Misdemeanor committed on February 4, 2018. The Defendant is assessed the statutory minimum fine of \$1,875.00 and a fifteen percent (15%) crime services surcharge of \$281.25, court costs, and restitution of all court appointed attorney fees. The Defendant is sentenced to ninety (90) days in the Osceola County Jail with all time suspended except for seven (7) days during a two (2) year formal probation to the Iowa Department of Corrections. The Defendant shall receive credit for time previously served for this offense.

October 20, 2020, Nyakor John Tongyik, age 25, of Sibley, IA was found guilty of the crime of Operating While Intoxicated, First Offense, committed on June 18, 2020. The Defendant is to pay a fine of \$1,250.00, a fifteen percent (15%) surcharge of \$187.50, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is sentenced to sixty (60)

days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for time already served.

October 20, 2020, Rhonda Romaine Hale, age 58, of Sioux Falls, SD was found guilty of the crimes of Assault on Persons Engaged in Certain Occupations, a Serious Misdemeanor, committed on October 29, 2019. The Defendant is to pay a fine of \$315.00, a fifteen percent (15%) surcharge of \$47.25, the costs of this action, and restitution of any court appointed attorney fees. However, the fine and 15% surcharge shall be waived. The Defendant is further sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for twenty (20) days which must be served. Hale also plead guilty to the amended charge of Felon in Possession of a Firearm, a Class D Felony, and Possession of Methamphetamine, an Aggravated Misdemeanor. The Defendant shall be placed in the custody of the Director of the Iowa Department of Corrections for an indeterminate term not to exceed five (5) years. This sentence shall be suspended and the Defendant shall be placed on probation to the Third Judicial District Department of Correctional Served for a period of two (2) years. The Defendant shall pay a \$750.00 fine, a 15% surcharge of \$112.50 and court costs of \$100.00. The Defendant shall be sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for twenty (20) days which must be served. This shall be served concurrently with the sentence imposed above. The Defendant shall receive credit for time previously served for these offenses.

October 20, 2020, Alisha Nicole Cannon, age 34, of East Sgt Bluff, IA was found guilty of the crime of Operating While Intoxicated, First Offense, committed on June 5, 2020. The Defendant is to pay a fine of \$1,250.00, a fifteen percent (15%) surcharge of \$187.50, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for time already served.

October 19, 2020, Jaime Sergio Valerio Gutierrez, age 43, of Sibley, IA was found guilty of the crime of Operating While Intoxicated, First Offense, committed on April 26, 2020. The Defendant is to pay a fine of \$1,250.00, a fifteen percent (15%) surcharge of \$187.50, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for time already served. Defendant may, at Defendant's own arrangement and expense, serve said sentence via Second Chances, the OWI 48 hour program in the Sioux City, IA.

October 16, 2020, Ronal Estuardo Gutierrez Ramos, age 37, of Sibley, IA was convicted of the crimes of Simple Misdemeanor Assault and Criminal Mischief in the 5th Degree, both Simple Misdemeanors. On the crime of Simple Misdemeanor assault the Defendant shall pay a fine of \$65.00, and a fifteen percent (15%) surcharge of \$9.75. The Defendant shall also pay the costs of this action, and restitution of any court appointed attorney fees. August 9, 2020, Narciso Flores Ramos, age 42, of Sibley, IA was arrested for allegedly Operating While Intoxicated - 1st Offense, a Serious Misdemeanor. Flores Ramos was also issued a citation for No Valid Driver's License. Flores Ramos was booked into the Osceola County Jail and released on a \$1,000 unsecured appearance bond. The Defendant is further sentenced to sixty (60) days in the Osceola County Jail, with all time suspended except for two (2) days during a two (2) year formal probation to the Iowa Department of Corrections.

The Defendant is to pay a fine of \$625.00, a thirty-five percent (35%) surcharge of \$218.75, the costs of this action, and restitution of any court appointed attorney fees. the Defendant is further sentenced to imprisonment in the Osceola County Jail for a term of ninety (90) days, with all time suspended except for ten (10) days. The Defendant is placed on probation to the Iowa Department of correction for a two (2) year formal probation.

Kropf was transported to the Osceola Regional Health Center by the Sibley Ambulance, Nguyen did not report any injuries. Kropf was issued a citation for Failure to Yield to Vehicle on Right.

When the deputy arrived the machine shed was fully engulfed and partially collapsed. The Harris Fire Department responded to the scene to put out the fire. The Sibley Ambulance also assisted at the scene.

February 10, 2020, Seth Michael Jurrens, age 38, of Little Rock, IA was found guilty of the crime of Operating While Intoxicated, Second Offense, committed on December 14, 2019. The Defendant is to pay a fine of \$1,875, a thirty-five percent (35%) surcharge of \$656.25, the costs of this action, and restitution of any court appointed attorney fees. An additional drug abuse resistance surcharge of \$10 is also assessed. The Defendant is sentenced to ninety (90) days in the Osceola County Jail with all time but seven (7) days suspended during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for time already served.

February 10, 2020, Jose Pinedo Curiel, age 26, of Sioux City, IA was found guilty of the crime of Operating While Under the Influence of a Controlled Substance, First Offense, committed on September 22, 2017. The Defendant is to pay a fine of \$1,250, a thirty-five percent (35%) surcharge of \$437.50, the costs of this action, and restitution of any court appointed attorney fees. An additional drug abuse resistance surcharge of \$10 is also assessed. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff. The Defendant shall receive credit for time already served.

On Friday February 7, 2020 at 8:30pm the Osceola County Sheriff's Office executed a search warrant at 431 4th Street in Ashton. Johnny Pierce, age 28, was arrested and transported to the

Osceola County Jail. Pierce was charged with alleged Possession of a Controlled Substance-Marijuana, a Serious Misdemeanor and Possession of Drug Paraphernalia, a Simple Misdemeanor. Pierce was held on a \$1300 cash/surety bond. The Osceola County Sheriff's Office was assisted by the Iowa State Patrol.

Deputies arrested Tiffany May McKee, age 29, and Amanda Leigh Fairbanks, age 37, both of Ashton. McKee was charged with possession of a controlled substance 1st offense-methamphetamine, unlawful possession of a prescription drug, both serious misdemeanors and also possession of drug paraphernalia, a simple misdemeanor. McKee was transported to the Osceola County Jail and held on a \$2,300 bond; and later released on a surety bond. The Defendant is to pay a fine of \$625, a thirty-five percent (35%) surcharge of \$218.75, the costs of this action, and restitution of all court appointed attorney fees. The Defendant shall be placed on informal probation for a period of one (1) year to the Osceola County Sheriff.

January 6, 2020, Amanda Lynn Christine Denoble, age 33, of Sibley, IA was found guilty of the crime of Driving While Barred, an Aggravated Misdemeanor. The Defendant is to pay a fine of \$625.00, a thirty-five percent (35%) surcharge of \$218.75, all court costs, the Sheriff's room and board fees, and court appointed attorney's fees. The Defendant is sentenced to imprisonment in the Osceola County Jail for ninety (90) days with eighty-six (86) days suspended with credit for time already served during a one (1) year informal probation to the Sheriff.

On Friday, January 3rd, 2020, the Osceola County Sheriff's Office executed a search warrant at a residence on 2nd Avenue in Ashton. Deputies arrested Alicia Marie Abrahamson, age 32, Justin David Haubrich, age 43 and Brandie Jo Vander Plaats, age 37, all of Ashton.

Abrahamson was charged with possession of controlled substance 1st offense-methamphetamine, a serious misdemeanor and possession of drug paraphernalia, a simple misdemeanor. Abrahamson was held on a \$1,300 bond.

Haubrich was charged with possession of controlled substance 2nd offense – methamphetamine, an aggravated misdemeanor and possession of drug paraphernalia, a simple misdemeanor. Haubrich was held on a \$2,300 bond.

Vander Plaats was charged with possession of a controlled substance 3rd offense – methamphetamine, fail to affix tax stamp and possession of marijuana with intent to deliver, all class D felonies. She was also charged with possession of drug paraphernalia, a simple misdemeanor. Vander Plaats was held on \$15,300 bond.
