## **2019 Press Releases**

December 29, 2019, an Osceola County Deputy arrested Marson Elnei Solomon, age 34, of Sibley, IA for alleged Domestic Abuse Assault, a Serious Misdemeanor. Solomon was transported and booked into the Osceola County Jail where he is being held on a \$1,000 bond. The arrest stemmed from a report of a disturbance at a residence in Sibley.

The sentence shall be served concurrently with the sentence imposed in Count 1.

An additional drug abuse resistance surcharge of \$10.00 is assessed. shall receive credit for time already served. The Defendant shall be allowed to serve said sentence via Second Chances, the OWI 48 hour program in Sioux City.

The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for six (6) days sixteen (16) hours fifteen (15) minutes already served during a one (1) year informal probation to the Sheriff.

October 15, 2019, Brandon Charles Selzer, age 38, of Melvin, IA was found guilty of the crime of Operating While Intoxicated - First Offense, a Serious Misdemeanor committed on September 17, 2019. The Defendant is sentenced to sixty (60) days in the Osceola County Jail with all time suspended except for two (2) days during a one (1) year informal probation to the Sheriff. The Defendant is sentenced to thirty (3) days in the Osceola County Jail with all time suspended except for six (6) days sixteen (16) hours fifteen (15) minutes already served.

October 8, 2019 at 3:00pm, Byron John Sharp, age 54, of Whitehall, MT was driving a 2007 Volvo Semi registered to Jarmer Manure Tanking Service of Fulda, MN. Sharp was turning southbound onto Monroe Ave from 140th St and failed to make a wide enough turn and the trailer was pulled into the ditch in the intersection. The trailer began to roll into the ditch and pulled the power unit into the ditch and rolled over completely. The Semi came to rest on the passenger side receiving approximately \$30,000 in damage. August 31. 2019 an Osceola County Deputy arrested Courtney Rose Kraus, age 23, of Lake Hallie, WI for allegedly Carrying Weapons, an Aggravated Misdemeanor, Possession of Controlled Substance - Marijuana 1st Offense, a Serious Misdemeanor, and Possession of Drug Paraphernalia, a Simple Misdemeanor. Kraus was also issued a citation for Speed. The arrest was the result of a traffic stop wt Hwy 60 and 130th St. A passenger in the vehicle, Quin Mitchel Kilmer, age 26, of Chippewa Falls, WI was also arrested and charged with Possession of Controlled Substance - Marijuana 2nd Offense, a Serious Misdemeanor, and Possession of Drug Paraphernalia. Kraus and Kilmer were transported and booked into the Osceola County Jail. Kraus was held on a bond of \$3,600 and Kilmer was held on a bond of \$1,300.

August 30, 2019, the Osceola County Sheriff's Office received a report of a vehicle rollover on 250th St east of Vine Ave. Joel Michael Kruger, age 64, of Sibley, IA was driving a 2001 Ford Explorer eastbound on 250th St. It appeared the Explorer dropped off the paved portion of the road onto the shoulder and lost control while trying to get back on to the road. The Explorer then overturned in the south ditch and came to rest on it's wheels. Kruger was fatally injured in the accident. The Iowa State Patrol, Sibley Ambulance and May City Fire Department assisted at the scene. The accident remains under investigation.

On Monday August 19, 2019 an Osceola County Deputy conducted a traffic stop on a motor vehicle in Ashton Iowa. During the traffic stop the driver of the motor vehicle refused to identify himself and he drove away. The Osceola County Deputy pursued the vehicle and during the pursuit, the vehicle reached speeds in excess of 100 miles per hour. During the pursuit an Officer with the Sheldon Police Department successfully deployed stop sticks on the vehicle. The driver of the motor vehicle then drove into Sheldon and once inside of Sheldon the driver took off on foot. The driver was apprehended by the Osceola County Deputy after a foot chase. The driver, Bruce Allen Flaugh Jr., age 34 of Hartley, IA, was charged with allegedly Eluding, a class D felony, Operating while Intoxicated- 2nd Offense, an aggravated misdemeanor, Possession of a Controlled Substance -Methamphetamine -1st Offense, a serious misdemeanor, two counts of Possession of Drug Paraphernalia, both simple misdemeanors, Driving while Suspended, a simple misdemeanor, and multiple other traffic offenses. Flaugh was transported to the Osceola County Jail and is being held on a \$6,300 cash or surety bond. The Osceola County Sheriff's Office was assisted by the Sheldon Police Department and the O'Brien County Sheriff's Office.

On Wednesday August, 7 2019 the Osceola County Sheriff's Office received a report of a vehicle in the ditch on Highway 59 near the intersection of 130th St. It was reported that the driver of the vehicle in the ditch was picked up by another vehicle and that vehicle had left the scene. Osceola County Deputies located and stopped the vehicle and as a result of the traffic stop, the driver of the vehicle, Brandon Michael Miller, age 28 of Round Lake, MN was arrested for allegedly operating while intoxicated -1st Offense. The driver of the vehicle involved in the accident, Amanda Kay Untiedt, age 36 of Sibley, IA was also arrested for allegedly operating while intoxicated -1st Offense. Miller and Untiedt were transported to the Osceola County Jail

and they were each held on a \$1,000 bond. Untiedt received minor injuries as a result of the accident and her vehicle, a 2013 Ford Explorer, sustained approximately \$8,000 worth of damage.

On July 27, 2019, the Osceola County Sheriff's Office and O'Brien County Sheriff's Office recovered stolen property taken from burglaries that occurred in O'Brien County, Osceola County, and Sioux County. Property recovered included a 2009 Honda dirt bike taken from a residence in rural Sioux County, 2 motorcycles and 1 dirt bike taken from Glen's Sport Center in Sheldon, another Honda dirt bike taken from a private residence in Sheldon, a 2004 Yamaha Raptor taken from a residence by Ashton, and a 2016 Arctic Cat 450 taken from a residence by Sibley. Also recovered were several ATV helmets, goggles, 9 handguns, and ammunition which were taken in a burglary that occurred at 59 Powersports in rural Osceola County. Most of the property was recovered in a wooded area west of Ocheyedan, IA. Charges are currently pending against a 17 year old juvenile male and 19 year old Isaiah Frederick, both of Ashton, IA. The Sheldon Police Department and Sioux County Sheriff's Office assisted in the investigation.

The Chevy received approximately \$15,000 in damage and the Dodge received approximately \$10,000 in damage. Conner and two juvenile passengers in the Chevy were transported to the Osceola Community Hospital by the Sibley Ambulance. Clark, a female passenger, and three juvenile passengers of the Dodge were transported to the Osceola Community Hospital by the Ashton Ambulance and Sibley Ambulance. Conner was issued a citation for Failure to Obey Stop Sign. Melvin Ambulance and Melvin Fire Department also assisted at the scene.

July 12, 2019 at approximately 2:55pm, Glenn Lorraine Doorenbos, age 90, of Sibley, IA was driving a 2010 Ford F150. Doorenbos was entering a parking space on the east side of the convenience store at Jackrabbit Junction. Doorenbos stated when he started pushing the brake pedal to stop, he also had his foot on the gas pedal. The F150 then crashed into the east side of the building and also struck an ice machine that was placed on the sidewalk along the east wall of the building. The impact from the F150 caused damage to the ceiling inside of the kitchen of Champs Chicken as well as the kitchen equipment. The F150 received approximately \$500 in

damage and the estimated damage to the convenience store was \$20,000. No injuries were reported.

June 4, 2019 an Osceola County Deputy arrested Travis Douglas Miner, age 37, of Ocheyedan, IA for allegedly Driving While Barred, an Aggravated Misdemeanor, and Driving While License Suspended. Miner was booked into the Osceola County Jail and released after posting a \$2,300 bond. The arrest stemmed from a traffic stop on 220th St near May City.

June 3, 2019, John Alfred Rivadeneira Mosquera, age 53, of Sibley, IA was found guilty of the crime of Operating While Intoxicated - Second Offense, an Aggravated Misdemeanor, committed on February 2, 2019. The Defendant is to pay a fine of \$65.00, a thirty-five percent (35%) surcharge of \$22.75, the costs of this action, and restitution of court appointed attorney's fees. The Defendant is further sentenced to imprisonment in the Osceola County Jail for a term of thirty (30) days with all time suspended during a one (1) year informal probation to the Osceola County Sheriff.

June 3, 2019, Philip James Murphy, age 36, of Primghar, IA was found guilty of the crime of Harassment in the Third Degree, a Simple Misdemeanor. The Defendant shall pay a \$65.00 fine, a 35% surcharge of \$22.75, restitution of any court appointed fees, if any and the costs of this action. The Defendant is sentenced to thirty (30) days in the Osceola County Jail with all time suspended during a one (1) year informal probation to the Osceola County Sheriff.

June 3, 2019, Tomas Morales Buchan, age 30, of Sibley, IA plead guilty to No Driver's License. The Defendant is ordered to pay a fine of \$200.00, a criminal penalty surcharge to thirty-five (35) percent, and the court costs of this case. The Court orders that the Defendant pay court costs in the amount of \$60.00. The Defendant is also sentenced to 30 days in the Osceola County Jail with all time suspended during one year of informal probation to the Osceola County Sheriff.

May 17, 2019 an Osceola County Deputy arrested Juan Jose Aguirre Gomez, age 26, of Sibley, IA for alleged Domestic Abuse Assault, a Serious Misdemeanor, and Obstructing Emergency Communications, a Simple Misdemeanor. Aguirre Gomez was transported and booked into the Osceola County Jail and held on a \$1,300 bond. The arrest stemmed from a report of a disturbance at a residence in Sibley.

May 16, 2019, Osceola County Deputies arrested Allen Gordon Rolfes, age 44, of Sibley, IA for alleged Assault on a Peace Officer, a Serious Misdemeanor, and Interference with Official Acts, a Simple Misdemeanor. The arrest stemmed from a report of a disturbance at a residence in

Sibley. When officers responded to the complaint, Rolfes is alleged to have become agitated and attempted to choke one of them. Rolfes was booked into the Osceola County Jail and held on a \$1,300 bond.

April 30, 2019 an Osceola County Deputy arrested Abimael Gomez Lopez, age 24, of Sibley, IA for allegedly Driving While Revoked, a Serious Misdemeanor. Gomez Lopez was booked into the Osceola County Jail and released after posting a \$1,000 bond. The arrest stemmed from a traffic stop on Hwy 60 at Exit 48.

April 30, 2019 an Osceola County Deputy arrested Matthew Alan Williams, age 37, of Milford, IA for allegedly Driving While Suspended, a Simple Misdemeanor. Williams was transported and booked into the Osceola County Jail where he was held on a \$300 bond. The arrest stemmed from a traffic stop at M18/White Ave and A34/220th St.

April 29, 2019, at approximately 5:36pm, James Ernest Gradert, age 24, of Sibley, IA was driving a 2012 Dodge R2500 southbound on Hwy 60 near 210th St. Timothy Blake Helmers, age 63, of Ashton, IA was driving a 2010 Harley Davidson. Gradert was overtaking another vehicle and did not see Helmers on the motorcycle. Gradert rear ended the Harley causing both vehicles to go into the west ditch and roll over. The Dodge received approximately \$20,000 in damage and the Harley received approximately \$10,000 in damage. Helmers was transported to the Osceola Community Hospital with non-incapacitating injuries by the Sibley Ambulance. Gradert was not injured. Gradert was cited for Unsafe Passing and Following too Closely. Assisting at the scene was the Ashton Ambulance and Ashton Fire Department.

April 23, 2019, the Osceola County Sheriff's Office received a report of a hit and run accident at 5th St and 4th Ave in Sibley. A legally parked 2003 Volvo S80 registered to Pedro Ortiz Zarate of Sibley, IA had been side swiped causing approximately \$4,000 in damage. Sheffield was transported and booked into the Osceola County Jail and held on a \$2,000 bond.

During the search, Deputies located multiple drug related items in two of the bedrooms including paraphernalia and packaging containing green plant material consistent with marijuana. After the search was complete, Deputies arrested, Matthew Glen Davids, age 22, for possession of a controlled substance – marijuana, a serious misdemeanor and possession of drug paraphernalia, a simple misdemeanor. Michael Johnathan Davids, age 29, was also arrested and charged for the same offenses. Cristee Ann Davids, age 50, who was already being held in the Osceola County jail, was also charged with possession of a controlled substance – marijuana and possession of drug paraphernalia.

Deputies also observed very poor living conditions inside of the residence. The main living area of the house was filled with miscellaneous items and trash which made it inaccessible except for a small walking path. The residence did not have running water or gas and only had a small heater to heat the upstairs bedrooms. The kitchen sink was filled with dishes which were full of mold and rotting food. The basement had been flooded with water for a quite some time which created a strong musty smell throughout the residence.

The Department of Human Services assisted by removing a 3 year old from the residence. The 3 year old shared a bedroom with father, Michael Davids and grandmother, Cristee Davids. In the immediate area of the 3 year old's sleeping area, Deputies located multiple pieces of drug paraphernalia and knives. As a result of all of the investigation, Michael Davids and Cristee Davids were both additionally charged with child endangerment, an aggravated misdemeanor.

Cristee Davids is being held on a \$3,800 bond. Michael Davids is being held on a \$3,300 bond. Matthew Davids is being held on a \$1,300 bond.

March 11, 2019, Shannon Delores Hagberg, 48, of Anthon, IA, plead guilty to OWI 1st, committed on August 29, 2018. The Defendant is to pay fine & surcharges of \$1797.50, the costs of this action, and restitution of any court appointed attorney fees. The Defendant is sentenced to 2 days in the Osceola County Jail with credit for time already served.

March 11, 2019, Jeremy Chad Simich, 33, of Granville, IA, plead guilty to 2 counts of Theft in the Fourth Degree, committed on May 4, 2018. The Defendant is to pay fine & surcharge of \$425.25 on each count, however the fine & surcharge are suspended. The Defendant must pay the \$125 Law Enforcement Initiative Surcharge, restitution for the Sheriff's room, board, and medical fees, restitution of all court appointed attorney fees and victim restitution to JackRabbit Junction in the amount of \$850.60. On each count, the Defendant is sentenced to 60 days in the Osceola County Jail with all time suspended except for 2 days to be served concurrently with each other, during a 2 year informal probation to the Osceola County Sheriff.

March 11, 2019, Andrew John Goldhorn, 35, of Sibley, IA, plead guilty to Public Intoxication, committed December 22, 2018. The Defendant is to pay a fine of \$65, a 35% surcharge, court costs and restitution of court appointed attorney's fees. The Defendant is sentenced to 30 days in the Osceola County Jail with all time suspended except for 16 hr, 26 min already served.

March 9, 2019 an Osceola County Deputy arrested Steven Craig Thompson Jr, age 39, of Sibley, IA for allegedly Operating While Under the Influence, a Serious Misdemeanor, and issued a citation for Open Container. Thompson was transported and booked into the Osceola County Jail and released on his own recognizance. The arrest stemmed from a traffic stop at 2nd Ave and 11th St in Sibley.

The Honda received approximately \$2,000 in damage and the Kia received approximately \$1,000 in damage. No injuries were reported.

March 4, 2019 an Osceola County Deputy arrest Allen Gordon Rolfes, age 44, of Sibley, IA for alleged Public Intoxication, a Simple Misdemeanor. Rolfes was transported and booked into the Osceola County Jail and released on his own recognizance. The arrest stemmed from a report of a disturbance at a residence in Sibley.

NICOTINE AND VAPOR PRODUCT EDUCATION AND ENFORCEMENT

Osceola County, Iowa (February, 2019) – The Osceola County Sheriff's Office has taken a pledge to keep tobacco, alternative nicotine and vapor products out of the hands of Osceola County youth.

Known as I-PLEDGE, the program is a partnership with the Iowa Alcoholic Beverages Division (ABD) to educate local retailers and to enforce Iowa's tobacco, alternative nicotine and vapor product laws. Since the program's inception in 2000, the statewide tobacco compliance rate has grown to 91%. By participating in the program, the Osceola County Sheriff's Office committed to do its part. Deputies conducted compliance checks on local establishments throughout Osceola County as part of the I-PLEDGE program. This year's underage illegal sales checks were 100% compliant.

I-PLEDGE places emphasis on retailer training. Clerks who successfully complete an online training course and then pass an exam will become I-PLEDGE certified. This allows a retail establishment to use an affirmative defense against a civil penalty if the certified clerk makes an illegal sale.

I-PLEDGE's retailer training is a great way for clerks to prepare themselves to refuse illegal tobacco, alternative nicotine and vapor product sales. The training also assists retailers to ensure they maintain a compliant and responsible establishment.

Underage customers, under the supervision of law enforcement officials, enter establishments and attempt to buy tobacco, alternative nicotine and vapor products. Clerks who make the illegal sale are cited on the spot.

Criminal penalties for selling tobacco, alternative nicotine and vapor products to a minor include a \$100 fine for a first offense, a \$250 fine for a second offense and a \$500 fine for third and subsequent offenses. However, handing out citations is not the intent of the I-PLEDGE program.

By partnering with the Iowa Alcoholic Beverages Division, we hope to educate clerks and maintain a compliant retail environment in our community. Moreover, we pledge to help keep tobacco, alternative nicotine and vapor products out of the hands of Iowa's youth.

February 26, 2019 Florinda Fernandez Ramirez, age 31, of Sibley, IA plead guilty to Driving While License Suspended. The Defendant is to pay a fine of \$250.00, a criminal penalty surcharge of thirty-five percent (35%), and the court costs of this case. The arrest stemmed from a traffic stop at 5th St and 5th Ave in Sibley.

February 25, 2019, Cory Joshua Reiter, age 39, of Sibley, IA was found guilty of the crime of Possession of Methamphetamine - 2nd Offense, an Aggravated Misdemeanor committed on March 25, 2018. The Defendant is to pay a fine of \$625.00, a thirty-five percent (35%) surcharge of \$218.75, all court costs, the Sheriff's room and board fees, and court appointed

attorney's fees. An additional drug abuse resistance education surcharge of \$10 and Law Enforcement Initiative Surcharge of \$125.00 assessed. The Defendant is sentenced to ninety (90) days imprisonment in the Osceola County Jail with all time suspended except for three (3) hours and forty-four (44) minutes. The arrest stemmed from a traffic stop on 2nd Ave and 11th St in Sibley.

February 21, 2019 at approximately 5:50pm Nathan Daniel Minten, age 31, of Sibley, IA was driving a 2002 Subaru Impreza southbound on 10th Ave. Austin Kruger, age 16, of Sibley, IA was driving a 2015 Ford F150 registered to Justin Kruger of Sibley eastbound on 9th St. Kruger was not able to stop at the stop sign due to the road conditions and slid through the intersection causing Minten to collide with the F150. The Subaru received approximately \$4,000 in damage and the F150 received approximately \$2,000 in damage. No injuries were reported.

February 21, 2019, Donna Patricia MacMain, 48, of Sibley, IA plead guilty to OWI 2nd Offense committed on October 13, 2018. The Defendant is to pay \$2507.50 for fine & surcharges, the costs of this action and restitution of any court appointed attorney fees. The Defendant is sentenced to imprisonment in the Osceola County Jail for 90 days with all but 7 days suspended during a 1 year informal probation to the Sheriff.

February 21, 2019, Susan Marie Dorman, 57, of Omaha, NE, plead guilty to OWI 1st Offense committed on July 18, 2018. The Defendant is to pay \$1697.50 for fine & surcharges, the costs of this action and restitution of any court appointed attorney fees. On February 15, 2019 at approximately 9:20am Frank Charles Zavorka, age 76, of Lennox, SD was driving a 2000 Chevy Express registered to SAE Warehouse, Inc of Sioux Falls, SD southbound on Redwood Ave. Donald Edward Frantz, age 68, of Rock Rapids was driving a 2013 Volvo Semi registered to Pete Klein Trucking of Rock Rapids westbound on Hwy 9. The Chevy slid through the stop sign and Frantz's vehicle struck it as it entered the intersection. The

Chevy then entered the north ditch and the semi came to a stop on Hwy 9. The Chevy received approximately \$5,000 in damage and the Semi received approximately \$15,000 in damage. Zavorka was transported to the Osceola Community Hospital by the Sibley Ambulance with incapacitating injuries. Frantz was not injured. Zavorka was issued a citation for Failure to Obey Stop Sign. Assisting at the scene was the Iowa State Patrol, Sibley Fire Department, Ocheyedan Fire Department, and Ocheyedan Ambulance.

On Monday, February 11, 2019, Kyle Thomas Ewinger pleaded guilty in Osceola County District Court to the amended charge of Sexual Abuse in the Third Degree, a Class C Felony, in violation of Iowa Code Sections 709.4(1)(a) and 903B.1. In pleading guilty, Defendant admitted in open court to performing a sex act by force or against the will of a 10-year-old child on October 3, 2015. At that time, the child was a fifth-grade student at Sibley Ocheydan Middle School in Sibley, Iowa. Defendant was the victim's teacher.

After the Court accepted Defendant's guilty plea, Defendant requested immediate sentencing and the Court proceeded to sentence Defendant to serve an indeterminate prison term not to exceed 10 years. Defendant was also sentenced to a special sentence committing him into the custody of the Director of the Iowa Department of Corrections for the rest of Defendant's life with eligibility for parole as provided in Chapter 906 of the Iowa Code. This special sentence shall commence upon the completion of the indeterminate 10-year prison sentence imposed by the Court. Defendant was further ordered to register for a sex offender for the balance of his life.

The Court further ordered that Defendant's 10-year prison term must be served consecutively to that imposed in Douglas County, Nebraska Case No. CR16-1706 wherein Defendant has previously been sentenced to serve a prison term of between 55 to 85 years in prison for sexually abusing a separate child. Defendant must serve 35 years in prison in Nebraska prior to being eligible for parole in Nebraska. Upon being paroled in Nebraska, Iowa authorities will then take custody of Defendant and he will then begin to serve his indeterminate 10-year prison term that was imposed in Osceola County District Court on February 11, 2019.

This case was investigated by the Osceola County Sheriff's Office and was prosecuted by Nolan McGowan, the Osceola County Attorney, with the assistance of Coleman McAllister, Assistant Iowa Attorney General.

February 2, 2019 an Osceola County Deputy arrested John Alfred Rivadeneira Mosquera, age 53, of Sibley, IA for allegedly Operating While Under the Influence 3rd Offense, a Class D Felony, Driving While License Denied or Revoked, a Serious Misdemeanor, and Driving While License under Suspension. Rivadeneira Mosquera was transported and booked into the Osceola County Jail where he is being held on a \$6,300 bond. The arrest stemmed from a traffic stop at 4th Ave and 4th St in Sibley.

February 2, 2019 at approximately 2:15pm, Jackie Dale Broesder, age 68, of Sibley, IA was driving a 2004 Chevy Trailblazer. Edward John Dagel, age 80, of Sibley, IA was driving a 1995 Buick Century. Broesder was backing from a parking spot at Jackrabbit Junction when she failed to see the Dagel vehicle and backed into it causing damage. The Trailblazer received approximately \$500 in damage and the Century received approximately \$1,000 in damage. No injuries were reported.

February 1, 2019 at approximately 4:40pm, Denise Lynn Truckenmiller, age 54, of Sibley, IA was driving a 2014 Chevy Equinox. Katherine Jane Walton, age 17, of Sibley, IA was driving a 2005 Pontiac G6. Both drivers were backing from parking spaces in the high school parking lot and did not see each other. The Equinox received approximately \$1,000 in damage and the G6 received approximately \$500 in damage. No injuries were reported.

February 1, 2019 at approximately 8:00am David E Kleinwolterink, age 60, of Sibley, IA was driving a 2012 Chevy Volt eastbound on 2nd St in Sibley. Verlyn Jeffrey Smidt, age 61, of Sibley, IA was driving a 2019 Peterbilt 520 garbage truck registered to the City of Sibley. Smidt stopped at the stop sign at the intersection of 7th Ave and 2nd St and continued northbound on 7th Ave, failing to see the Kleinwolterink vehicle. The Chevy struck the garbage truck broadside. The Chevy received approximately \$12,000 in damage and the garbage truck received approximately \$5,000 in damage. Kleinwolterink was transported to the Osceola Community Hospital with possible injuries. Smidt was not injured and received a citation for Failure to Yield Upon Entering a Through Highway.

January 31, 2019, Timothy Allen Lamfers, 58, of Sibley, IA, plead guilty to Flight to Avoid Prosecution, committed on June 28, 2001. The Defendant is to pay fine & surcharges of \$1012.50, restitution of any court appointed attorney fees, and the Sheriff's Room & board fees. The Defendant is sentenced to the custody of the Director of the Iowa Dept. of Corrections for a term not to exceed 5 years, however, this sentence of incarceration is suspended and the Defendant is placed on probation to the Iowa Dept of Corrections for a period of 2 years.

January 28, 2019 at approximately 12:19pm, Mark Alan Kruger, age 58, of Ocheyedan, IA was driving a 2007 International 7000 registered to the Iowa Department of Transportation. Vernon Dale Bolkema, age 74, of Sibley, IA was driving a 2013 Chrysler Town & Country. Kruger was sanding the intersection on the west on ramp of A22 and Hwy 60. Kruger did not see the Bolkema vehicle pull up behind him at the stop sign and backed into the Chrysler's front end. The Chrysler received approximately \$1,500 in damage and the International was not damaged. Kruger was cited for Unsafe Backing. No injuries were reported.

January 26, 2019 at approximately 10:15am, Brandon Thomas Schulz, age 30, of West Bend, IA was driving a 2007 Kenworth Semi registered to Kritter Trucking of West Bend southbound on Hwy 60. William G Medley, age 49, of Lincoln, NE was driving a 2010 Ford F150, also southbound on Hwy 60. Schulz was passing Medley in the passing lane. Due to the slippery road conditions, the F150 was pulled into the side of the passing Semi side swiping it. The Kenworth received approximately \$500 in damage and the Ford received approximately \$2,000 in damage. No injuries were reported.

January 22, 2019, at approximately 4:40pm, Nicole Keasling, 20, of Hartley, IA, was driving a 1999 Chrysler 300 northbound on Tyler Ave when the driver lost control on the ice covered road. The vehicle ran off the roadway to the left and rolled into a canal filled with water. The driver and passenger were transported to the Osceola Community Hospital by the Osceola County Ambulance Service. The vehicle sustained approximately \$9000 damage.

January 20, 2019 at approximately 6:20pm Susana Elizabeth Beckman, age 75, of Windom, MN was backing a 2004 Pontiac Grand Prix registered to Sharon Cree of Sibley, IA from a driveway on 8th Ave in Sibley and backed into a legally parked 2011 Mitsubishi Lancer registered to Adrian Goytia of Fort Bliss, TX. The Pontiac received approximately \$400 in damage and the Mitsubi1shi received approximately \$1,500 in damage. No injuries were reported.

January 20, 2019 at approximately 6:20pm Susana Elizabeth Beckman, age 75, of Windom, MN was backing a 2004 Pontiac Grand Prix registered to Sharon Cree of Sibley, IA from a driveway on 8th Ave in Sibley and backed into a legally parked 2011 Mitsubishi Lancer registered to Adrian Goytia of Fort Bliss, TX. The Pontiac received approximately \$400 in damage and the Mitsubi1shi received approximately \$1,500 in damage. No injuries were reported.
